Diverse Status Definitions

- **Woman-owned Business:** Company must be at least 51% owned and controlled by one or more U.S. citizens who are women.
- **Minority-owned Business:** Company must be at least 51% owned and controlled by one or more U.S. citizens who are ethnic minorities*.
- **Veteran-owned Business:** Company must be at least 51% owned and controlled by one or more U.S. citizens who are veterans.
- **Service-Disabled Veteran-owned Business:** Company must be at least 51% owned and controlled by one or more U.S. citizens who are service-disabled veterans.
- **Persons with Disability-owned Business:** Company must be at least 51% owned and controlled by one or more U.S. citizens who are persons with disabilities.

Size Definitions

- **Small Business:** Company qualifies as a small business under the criteria and size standards in 13 CFR 121 (see FAR 19.1). See <http://www.sba.gov/content/small-business-size-standards> for details.
- **Small Disadvantaged Business:** Company must qualify as a small business (defined above) and be at least 51 percent owned by one or more individuals who are socially and economically disadvantaged. See <http://www.sba.gov/content/disadvantaged-businesses>.
- **HUB Zone:** A business located in a Historically Underutilized Business district and certified by the Small Business Association. See <http://www.sba.gov/category/navigation-structure/contracting/working-with-government/small-business-certifications-audiences/hubzone-certification>.
- **Large Business:** Company does not qualify as a small business (defined above).

*Ethnic Minority Definitions

- **Asian American:** A U.S. citizen whose origins are from India, Pakistan, Bangladesh, Japan, China, Indonesia, Malaysia, Taiwan, Korea, Vietnam, Laos, Cambodia, the Philippines, Thailand, Samoa, Guam, or the U.S. Trust Territories of the Pacific or the Northern Marianas
- **Black or African American:** A U.S. citizen having origins in any of the Black racial groups of Africa.
- **Hispanic American:** A U.S. citizen of true-born Hispanic heritage, from any of the Spanish speaking areas of the following regions: Mexico, Central America, South America and the Caribbean basin only.
- **Native American:** person who is an American Indian, Eskimo, Aleut or Native Hawaiian, and regarded as such by the community of which the person claims to be a part. Native Americans must be documented members of a North American tribe, band or otherwise organized group of native people who are indigenous to the continental United States and proof can be provided through a Native American Blood Degree Certificate (i.e., tribal registry letter, tribal roll register number).
