4. How to Enter: During the Promotion Period, visit https://webform.wd.lenovo.com/webforms/Signup/LEDSWP19 and follow the links and instructions to complete the registration form including your full name and a valid email address to subscribe to receive email marketing communications from Sponsor. You automatically will receive one (1) entry into the applicable Monthly Entry Period drawing associated with the time and date you complete and submit the form. **NOTE:** You may unsubscribe from email communications at any time without impacting your Sweepstakes entry.

<u>Limit</u>: You may enter one (1) time during the Promotion Period and will only be included in one (1) Sweepstakes drawing. Multiple entrants are not permitted to share the same email address.
